The City is authorized to expend an amount to exceed Three Million, Thirty-four Thousand, Nine-Hundre Twenty and 00/100 Dollars (\$3,034,920.00) which includes subscription costs for Phase I, Phase II, Phase IIIA and Phase IIIB.
