A Resolution authorizing the Mayor to execute a three (3) year Agreement for Annual Subscription Services Agreement with SoundThinking, Inc., to provide for renewal and hosting of the ShotSpotter Gunshot Detection, Location, and Forensic Analysis Service within the City. The existing Agreement ends September 30, 2025, and this new Agreement will cover ShotSpotter Subscription Services commencing October 1, 2025, and ending September 30, 2028. The City is authorized to expend an amount not to exceed Three Million, Thirty-four Thousand, Nine-Hundred Twenty and 00/100 Dollars (\$3,034,920.00) which includes subscription costs for Phase I, Phase II, Phase IIIA and Phase IIIB.
