# **ORDINANCE/RESOLUTION**

**7.**

An Ordinance, pursuant to §41-9-591(a) Code of Alabama and Alabama Act 1969-916, authorizing the Mayor or the Chief of Police to execute a User Agreement between the Alabama Law Enforcement Agency (ALEA) and the City of Birmingham for the Birmingham Police Department, for a term of up to three years, to ensure and define the responsibilities of ALEA and the BPD related to the BPD's access to ALEA State Bureau of Investigation Criminal Justice Information Services Division (ALEA CJS) information system. The City shall be authorized to pay an amount which shall not exceed Seven Hundred Thirty-six Thousand Five Hundred Sixty and 00/100 Dollars (\$736,560.00) with \$245,520 to be paid in FY2026, \$245,520 to be paid in FY2027 and \$245,520 to be paid in FY2028. The Funding Source for this Agreement shall be G/L # 001\_037\_01920\_01922.526-001 (IMS-Systems Development-System Support, Technology Maintenance-Software Maintenance).
