An Ordinance, pursuant to Alabama Act 1969-916, the Mayor to execute an Interlocal Agreement between the City of Birmingham (City) and the Housing Authority of the Birmingham District (HABD), to provide a law enforcement task force and Community Safety Partnership related to HABD’s High-Intensity Community Oriented Police Patrol Program at designated HABD properties for a period of up to two (2) years, with an end date of May 21, 2028 unless terminated earlier by either party. HABD will provide funding to the City in an amount not to exceed Two Million Three Hundred Sixty-eight Thousand Five Hundred Sixteen and 32/100 Dollars (\$2,368,516.32) to cover personnel costs, expenses, and reimbursement for maintenance, fuel and repair of vehicles. The City will provide up to Seven (8) police officers, one (1) sergeant and one (1) lieutenant to perform law-enforcement functions in the housing communities as part of the Task Force.
