A Resolution pursuant to §11-40-1, §11-43-55, §11-43-140, and §41-16-51(a)(18), Code of Alabama, 1975 authorizing the Mayor to execute and deliver an agreement with Motorola Solutions, Inc. to provide Mobile Radio Maintenance Service and related accessories, repair parts, software and components at the unit prices under the same terms and conditions as provided in the Alabama Buys e-procurement system statewide contract (State Contract Number: MA230000003341-2). The term of the service agreement shall not exceed two years and shall end on June 30, 2028 (the "Term"). The total compensation to be paid to Motorola Solutions Inc. under this Agreement shall not exceed Seven Hundred Thirty-one Thousand Six Hundred Forty-three and 37/100 Dollars (\$731,643.37), and available Motorola Credit shall be used to cover this entire purchase resulting in no municipal funds due to be paid by the City to Vendor under this Agreement.

A Resolution to authorize the Mayor, in accordance with §11-43-140, Code of Alabama, to execute a one-year Agreement with the University of Alabama Health Services Foundation, P.C., to provide consultant services of professionally trained medical personnel to assist the BFRS regarding public health, community paramedicine and other means of improving the health and well-being of citizens. The term of the Agreement shall begin on October 1, 2026, and end on September 30, 2027.
